



## KILGORE COLLEGE REAL ESTATE PROGRAM

The Texas Real Estate Commission (TREC) requires 6 courses to be completed successfully before you can apply with them to take your Exam for becoming a licensed Real Estate Sales person. You can go to the TREC website at [www.trec.texas.gov](http://www.trec.texas.gov) for more information.

We have our classes scheduled so that IF you are able, you can take 2 classes at a time (4 days/week) you can complete all 6 courses in 1 semester. You can also take 1 class at a time (2 days/week) and you can finish half of the courses in one semester and the other classes the next semester. We offer the complete program from the beginning at each Fall and Spring semester. Our instructors are experienced and successful Real Estate professionals.

Morning classes available in Kilgore 9am-noon and Evening classes available at KC-Longview 6-9pm. Principles I is the first course that you need to take as it provides information that will carry on to the other courses. I have attached the current 2024-25 FALL Semester schedule. I have also attached a registration form that you can complete and scan/email to me. ***Please indicate if you want the Morning or Evening classes.***

The course cost will **include** the textbook for each course! Each course is \$200.00 / The complete program is \$1200.00 You do not pay for the complete program up front – you pay **ONLY** for the class(es) you are about to start.
